Its solvent-free formula safely cleans floors, walls, wood, ceramic, linoleum, metals, concrete, plastics, vinyl, porcelain, glass, garbage areas, countertops, bathroom and kitchen tiles, sinks and toilets.

#### DIRECTIONS FOR USE:

For best results, dilute using the recommended concentrations. **Light Duty Cleaning:** 1:64 or 2 oz/gallon. **Medium Duty Cleaning:** 1:32 or 4 oz/gallon. **Heavy Duty Cleaning:** 1:8 or 16 oz/gallon. **Spray bottle:** Using recommended dilutions, apply cleaner onto soiled surfaces and wipe away. For hard to remove stains allow for longer contact time before wiping. **General Floor Cleaning:** Using 1:64 or 2 oz/gallon, add cleaner into your mop bucket or auto-scrubber.

**NOTE:** In order to conserve energy, please use unheated tap water for all dilutions. Rinse all food contact surfaces with potable water before reuse. Do not let product spoil food, feed or potable water during use. The amount of product used should not be in excess of that required to achieve its intended technical effect.

**STORAGE:** Keep in a tightly sealed container in a well-ventilated room. Do not store on surfaces that may come into contact with food products. **KEEP FROM FREEZING**
