Its solvent-free formula safely cleans floors, walls, wood, ceramic, linoleum, metals, concrete, plastics, vinyl, porcelain, glass, garbage areas, countertops, bathroom and kitchen tiles, sinks and toilets.

DIRECTIONS FOR USE: For best results, dilute using the recommended concentrations.

Light Duty Cleaning: 1:64 or 15 ml per litre. Medium Duty Cleaning: 1:32 or 30 ml per litre. Heavy Duty Cleaning: 1:8 or 120 ml per litre.

Spray bottle: Using recommended dilutions, apply cleaner onto soiled surfaces and wipe away. For hard to remove stains allow for longer contact time before wiping.

General Floor Cleaning: Using 1:64 or 60 ml per 4 litres, add cleaner into your mop bucket or auto-scrubber.

NOTE: Test on an inconspicuous area prior to use. All surfaces subject to direct food contact must be thoroughly rinsed with potable water before reuse.

STORAGE: Keep in a tightly sealed container in a well ventilated room. Keep from freezing.
