Safeblend Neutral Cleaner Ultra Concentrated safely cleans all washable surfaces using a neutral pH concentrated formulation. It is ideal for daily floor maintenance and general hard- surface cleaning leaving floors with a streak free shine without damaging or removing floor finish.

DIRECTIONS: General Cleaning: Set SafeMix Dilution Control System to the high flow dilution setting (pushing in the 'bucket' button completely). Safeblend Neutral Cleaner Ultra Concentrated will automatically be diluted at a 1:256 ratio. Fill bucket using the SafeMix Dilution Control System. Place hose at the bottom of the bucket to avoid excess foaming. Apply cleaner with a mop, autoscrubber, cloth, sponge, etc. Spray bottle: Set SafeMix Dilution Control System to the low flow dilution setting (pushing in the 'bottle' button completely) Safeblend Neutral Cleaner Ultra Concentrated will automatically be diluted at a 1:128 ratio. Fill bottle with the SafeMix Dilution Control System. Place hose at the bottom of the bottle to avoid excess foaming. Spray on surface to clean. NOTE: The amount of product used should not be in excess of that required to achieve its intended technical effect. Rinse all food contact surfaces with potable water before reuse. Do not let product spoil food, feed or potable water during use. STORAGE: Keep in a tightly sealed container in a well-ventilated room. Do not store on surfaces that may come into contact with food products. KEEP FROM FREEZING.
